


Message from the Board

Planned Giving – good for you and the charities you support

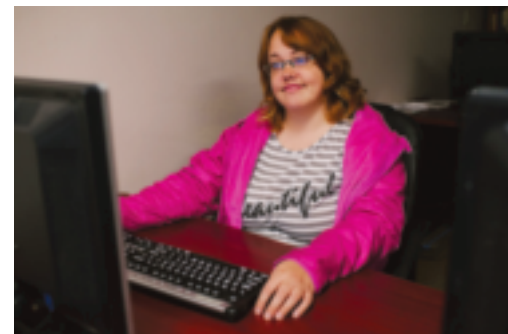

Creating opportunity and a better life for adults with intellectual disability



The story of Summer Street is told in the lives of our clients. We work together with people with intellectual disability to discover opportunities, and with the community to create awareness of the skills, talents and gifts that everyone has to offer.

Our programs provide education, independence, employment and pride of accomplishment for 185 people annually. In 2016, our clients contributed 14,600 volunteer hours in the community and earned \$700,000 through employment (an increase of \$150,000 in the last three years). In an average year over 20,000 people pass through our doors. They buy products, attend functions, donate, volunteer, visit, and share in our success.

With over 5,000 customers, 2,000 donors, 185 current clients and a vast network of friends and business partners, Summer Street is an integral part of the community. Through our programs, social enterprises and numerous annual events, we are opening doors and eliminating barriers for everyone.

The Summer Street Foundation is a registered charity, founded in 1991 to lead fundraising and provide financial support for all of Summer Street's programs, services and enterprises.
